Step 1

<u>Team Contact Information</u>: Complete online form with general club and contact information.

Step 2

<u>Team Participation Agreement</u>: This form must be signed and dated by your team representative, as well as LAU and TU Officials. This affirms that you understand what is required of you and your team at a USA Rugby National Championship event.

Step 3

**If any rostered member of your team has received an eligibility waiver for any purpose, please include a copy of that waiver along with your form.

<u>Senior Club 15s Roster & Checklist</u>: To be completed prior to competition in a USA Rugby Senior Level Championship Event.

Step 4 – Turn in at Check-In

<u>Participation Waiver - Adult (REQUIRED for all participants 18 years of age or older)</u>: This form must be signed and dated by all participating championship players 18 years of age and older. A copy of this form must be turned in at team check-in.

<u>Participation Waiver - Minor (REQUIRED for all participants under the age of 18)</u>: This form must be signed and dated by all participating championship players under the age of 18, as well as by the player's parent or legal guardian. A copy of this form must be turned in at team check-in.
